Temperatures are favored to average warmer than normal. Precipitation is expected to total drier than

normal. Much of the first half of the month will be on the dry side with our best prospects for showers coming on November 3, 9, and 11. Precipitation prospects are expected to be most promising from November 21-24. A mix of rain and snow are favored for November 28-29.

Great November Storms,

The wreck of Edmund Fitzgerald, November 10, 1975. Made popular by Gordon Lightfoot's song about "The Wreck of the Edmund Fitzgerald." The Edmund Fitzgerald was a large 729-foot ore carrier that sank in Lake Superior. With the loss of its 29-man crew the Edmund Fitzgerald sank when winds over 60 mph and waves as high as 16 feet overwhelmed the iron ore carrier, which sank in 550foot Lake Superior waters.

November Astronomy Calendar

Our days are getting shorter and our nights are getting longer. We lose about an hour of daylight this month. We do gain an hour of sleep as daylight saving time ends on Sunday, November 4, (turn back the clock 1 hour). Thanksgiving falls on the day of the full moon, November 22.

Mercury is an evening planet this month, rising after sunrise and setting shortly after sunset. Mercury will be very tough to see as it will be low in the western sky at sunset. Better viewing opportunities will come in December when Mercury becomes a morning planet.

The moon is New on Wednesday, November 7.

Venus transitions to a morning planet this month. It will be

tough to spot the opening days of the month but look for Venus in the southeast sky before sunrise. Venus will be to the right of the waning new moon the morning of Tuesday, November 6. Close to Venus throughout the month is the star Spica, part of the constellation Virgo.



What more can I say about the planet Mars? It has been a spectacular past few months of viewing.

Rising during the early afternoon hours, Mars will be visible in the south southeast sky at sunset. The first quarter moon will be near Mars the evening of Thursday, November 15.

The moon is Full on Thursday, November 22.

Jupiter will be lost in the sun's glare all month.

Saturn will be viewable after sunset in the south southwest sky throughout the month. Look for Saturn below the waxing crescent moon the evening of Sunday, November 11.

Morning Planets: Venus

Evening Planets: Mercury (1-21), Mars, Jupiter, and Saturn.

Long Range Weather Outlook... From White of Winter to Green of Spring.

January expect warmer than normal temperatures with above normal precipitation.

February outlook favors warmer than normal temperatures with near normal precipitation.

March expect near normal temperatures with near normal precipitation.

April outlook favors warmer than normal temperatures and near normal precipitation.

May outlook favors cooler than normal temperatures and above normal precipitation.
